**Awareness, involvement,  
sharing information help  
deter and prevent**

You don't have to refer to statistics or official trend analyses to be aware of crime in the Kansas City metropolitan area. A quick glance at the headlines in the paper or the television reports show many of the most serious problems facing the city. Many of us supervise security officers and employees who report incidents of all kinds around the city. Each of us manage and direct security programs that contribute to the safety and security of our companies and employees. The city benefits indirectly from our efforts. Is there more we could do to reduce crime and improve our environment? What should we be doing?

Being aware of what is going is critical. Routine sources of information are reliable in helping with awareness. Only a few weeks ago, police reported a number of victims in Johnson County who had their homes burglarized. The reason? Victims left their garage door openers in their cars along with mail or other identifying papers. This effectively gave the criminals a map and a key. Now the Kansas City, Missouri Police Department is reporting similar crimes in central, and even north Kansas City. A preventable trend that frustrates detectives almost as much as victims.

When reading a story or watching a televised news report, we should be focused on prevention strategies. Many crimes of opportunity are reported every week that serve as training material for our security officers and employees.

Two crimes that are especially concerning to police recently are auto thefts and carjackings. Only days after a fatal carjacking made the top news story, a child was left alone in a vehicle, and another tragedy was barely avoided. The message was clear: leaving kids alone in cars is an invitation to disaster. Police continue to report vehicle thefts and stealings from vehicles as the result of vehicles left unlocked or valuables left in plain sight. No matter how many times people are told, they continue to provide the opportunity a criminal looks for.

These are areas we need to continuously emphasize to our employees. The simple, “common-sense” actions are the most effective in preventing crime (locking doors, not leaving valuables in plain site, parking in well-lit areas, being aware of surroundings, etc.). Sending out reminders when a news story has already captured the attention of people is an effective way of making the point. And we should be as interested in preventing incidents on company property as we are away from work. The resulting loss still impacts each of us.

Besides newspapers and television, there are many other resources available to security managers for identifying crime trends in Kansas City. The Association of Security and Police (ASAP) is a group that meets every month to share information about incidents and suggest methods of prevention. Both security and law enforcement professionals attend the meetings, and it is time well spent. Contact Ed Spalding for more information (see his article on page 9). Make time for this once a month and schedule your awareness training around it.

An example of information gathered recently at an ASAP meeting is the number of office thefts occurring around the city. Downtown office buildings are prime targets for active thieves. Insecure wallets, purses, laptop computers, and other equipment are among the most popular items stolen from office areas. Again, training employees to be aware of strangers, and to secure property is essential in curbing this trend. Taking away the opportunity goes a long way in making the entire city safer.

Theft and forgery of checks and credit cards is a crime that continues to increase as the technology to produce cards and checks becomes easier to obtain.

Awareness, training, and good fortune recently led to the arrest of three individuals who purchased thousands of dollars worth of merchandise with counterfeit and stolen credit cards. Overland Park Police officers responded to the Oak Park Mall and apprehended the thieves after attentive officers observed suspicious behavior and reported it. In this case, training and education paid off, and more crime was certainly prevented.

Almost everyone in Kansas City is familiar with Crime Stoppers and the Tips Hotline (see next page). The Crime Stoppers website has a variety of information on crime in Kansas City, as well as prevention tips and

resources. Visit the site and become involved in the programs available.

# Overland Park PD arrests foreign thieves, recovers \$50K in property

## “Positional luck”, key observation, leads to arrest of three

An Overland Park police officer used the observation skills taught at the police academy to initiate a successful apprehension of three foreign men at the Oak Park Mall on March 12. Officer Richard Medley was responding to the mall on an unrelated shoplifting complaint when he noticed a man talking into a radio. Medley asked a security officer if the man was with the security department. When it was confirmed that the man was not a security officer, Medley quickly reported the suspect to his superiors.

Sergeant John Jackson, an academy instructor with the OPPD, said he responded to the scene after receiving the call from the officer. When he and other officers arrived at the mall, they quickly identified the original suspect, and followed him to a van parked outside. After the suspect left the van, officers observed credit cards inside. Sergeant Jefferson, who worked in the financial crimes/fraud unit for seven years, was able to identify the numbers on the cards right away as being counterfeit.

The suspects were followed and observed for a time as they made several thousand dollars worth of purchases with counterfeit credit cards. Once enough evidence was gathered, the officers moved in and made the arrest. Jackson said that one of the suspects made an attempt to flee the scene, but was apprehended without incident. Sergeant Jackson said that the cards had been counterfeited with stolen numbers. He added that the numbers were stolen from out of the local area. The Secret Service has taken over that part of the investigation.

It was not immediately known where the suspects were from, but a Taiwanese passport was discovered

among credit cards and purchased items. The three were clearly not from Kansas City. Jackson said it would turn out to be “a much longer stay in Kansas City than they had planned”. During questioning, the suspects told Sgt. Jackson that they specifically targeted the Midwest because of a perception of a lack of professionalism and experience by law enforcement compared to large cities like New York or Los Angeles. While there may be shortcomings in technology in some jurisdictions across the Midwest, this incident proves that people can make all the difference.

The Overland Park officers recovered about \$50,000 worth of merchandise purchased illegally from stores at the Oak Park Mall. The merchants were obviously pleased to know their goods were recovered and would be returned intact. “Fifty thousand makes up for a lot of shoplifting,” Jackson said.

Was it “luck” that led to the apprehension of the trio? Not quite, according to Sgt. Jackson, “Positional luck,” he said, “not just blind luck. It’s a matter of placing yourself in a position to make an observation such as this.” He said that Officer Medley did exactly as he was taught, paying attention to his surroundings, and looking for unusual activities. The “positional luck” Sgt. Jackson referred to is a lesson all of us should include in our security awareness and training. Officer Medley sets a perfect example for security officers, employees, and supervisors in every company in Kansas City. So much crime could be avoided with alert, attentive people ready to report unusual activities.

Congratulations to the entire team of professionals at the OPPD, and thanks to Sgt. Jackson for sharing his experience with us.



## Association of Security and Police (ASAP) brings police, security together in KC

Do you struggle with the concept of Community Oriented Policing (COP) and wonder how private security fits in COP? Would you like to belong to a group where you do not have to pay annual dues? An informal group of private security company representatives and KCPD Property Crime Unit representatives began in late 1994, with the idea of improving communications between the KCPD and private security licensed to operate in the KCMO area.

The idea of organizing this grass roots COP group began with then Major Louis Quijas and Sgt. Doug Weishar of the Property Crimes Unit, KCPD. These individuals, along with others in private security, saw the value of sharing information in order to help reduce crime in the city. With their efforts, and those of some dedicated private security professionals, the meetings began on a regular basis in early 1995. In that same year it was decided that this informal group needed a name, so, after considering suggestions by the group and a vote taken, the name of Association of Security and Police (ASAP) was adopted. A steering committee for the ASAP also was formed in order to better plan for meetings and give general direction to the group.

Discussion of current crime trends and general sharing of information has been the main focus behind the meetings from the beginning. Efforts early on were made to have a quarterly shoplifting bulletin and develop an automated communication system in order to quickly share information among the various security groups. Also besides sharing information about criminal activity, the group has had presentations on such subjects as cell phone cloning, robbery, bombs, counterfeiting, MO Gaming operations, health care security, retail security, and countermeasures to name a few.

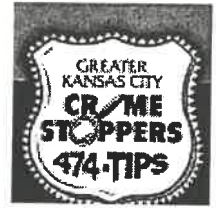
Although the Telephone Alert Network was abandoned in 1998, the ASAP group continues to meet on the third Wednesday of each month at one of Kansa City power and Light's facilities to share information on crime trends in the city.. The group still has representatives of KCPD Property Crimes units and interested area licensed private security company representatives.
